Thank you for choosing South Carolina Student Loan Corporation (SCSL) as your education loan provider. It has been our pleasure to assist you in pursuing your educational goals. We would like to take this opportunity to provide you with important information regarding your Federal Student Loan(s).

You may recall that in 2010 the federal government eliminated the Federal Family Education Loan Program (FFELP) and mandated that all federal student loans made on or after July 1, 2010, be originated by the U.S. Department of Education. This action on the part of the federal government removed SCSL's ability to continue to originate federal student loans.

Over the past 6 years, as your South Carolina based non-profit partner, SCSL has continued to service your FFELP loans that were originated before July 1, 2010; however, during this period our FFELP student loan portfolio has significantly decreased due to the normal paydown of loans. Therefore, we have transferred the servicing of your federal student loan(s) as indicated below to National Education Loan Network (Nelnet) effective August 19, 2016.

Nelnet will send you a welcome letter over the next few weeks with additional information on setting up a borrower account and making payments on your federal loans. All future payments and correspondence pertaining to the federal loans listed above should be directed to Nelnet at 888-486-4722, but we will gladly forward payments and correspondence for up to 60 days. If you were enrolled in our automatic bank draft program, Nelnet will continue to draft your bank account for the monthly payment due on your FFELP loans. If you wish to make any changes to your bank draft arrangement on your FFELP loans, you will need to contact Nelnet directly.

Please note that we will continue to service both Palmetto Assistance Loans (PAL) and SC Teachers Loans that you may have with us. All payments and correspondence pertaining to these private loans should continue to be submitted to SCSL, and existing bank drafts by SCSL will continue for PAL and SC Teachers Loans unless you notify us of a change.
